The main objective of the role is to keep the Saffron Walden Hub in a clean and orderly condition, carrying out weekly cleaning duties in accordance with in house health and safety guidelines.

# Key Task Areas and Responsibilities:

- All bins to be emptied and wiped down twice a week.
- Polish all surfaces and desks where desks have been left clear.
- Hoover all carpets.

- Mop kitchens and toilets.
- Kitchen surfaces and doors to be washed down and all sinks to be cleaned.
- Dust all high level areas.
- Bathrooms to be cleaned and bleached.
- Fridges to be cleaned when required and kept to an acceptable hygiene level.
- All mirrors to be cleaned.
- Place orders for cleaning supplies when required.
